The Pennsylvania Governor's Office of General Counsel seeks a licensed attorney to work as an Assistant Counsel in the Pennsylvania State Police (PSP) Office of Chief Counsel. The position will be classified as either an Attorney 1, 2, 3 or 4 depending on the level of relevant experience possessed by the successful applicant. The position will be based in Harrisburg and is eligible for part-time telework with an in-office requirement of three business days per week at the discretion of the General Counsel.

The PSP Office of Chief Counsel provides advice to the PSP on a variety of legal issues including transactional and regulatory matters, along with several PSP program areas with duties requiring specific and unique legal needs including, but not limited to, PSP's Legislative and Policy Office, Bureau of Forensic Services, Bureau of Patrol, Megan's Law Section, PSP's Firearms Division, and the Pennsylvania Criminal Intelligence Center (PaCIC). Attorneys within the PSP Office of Chief Counsel also represent and advise the Municipal Police Officers' Education and Training Commission (MPOETC).

The attorney hired for this position can expect that a significant part of their duties will involve legal review of proposed legislation that will impact PSP operations and advising the Legislative and Policy Office on how to manage the proposed legislation. Additional duties include assisting in the management of PSP's regulatory drafting and review process through advising the departmental stakeholders and the Legislative and Policy Office on the requirements of the Regulatory Review Act. Finally, the attorney hired for this position will represent PSP and its members before administrative tribunals and state/federal courts on various matters.

The successful candidate for this position will have: (1) solid legal research, analysis and reasoning capabilities; (2) excellent inter-personal and communication skills, especially oral and written advocacy; (3) an ability to quickly identify and resolve complicated and sensitive problems creatively and with professional discretion; (4) an ability and willingness to handle a wide variety of complex legal matters both independently and as part of a team; (5) an ability to interact and function effectively within the Office, the greater legal community and a governmental organization, and (6) an ability to travel regularly.
